Froglife Gift Aid Declaration

Gift Aid is a huge help to us, enabling us to benefit from an extra 25% from the Inland Revenue on the amount that you donate.

In order for us to claim this, we need to know that you have paid enough tax to cover that 25%, as well as 25% of your donations to other charities within a tax year (6th April to 5th April). Generally these amounts are quite small, for example:

- On a standard £18 Froglife Friendship, we can claim an extra £4.50
- on a £36 Friendship donation it would be £9
- on a £50 donation it would be £12.50
- on a £100 donation it would be £25
- on a £500 donation it would be £125.

If you do pay enough tax to cover the relevant amount, we would really appreciate it if you could take the time to complete the form below and send it back to us.

Please treat as Gift Aid all qualifying donations made to Froglife (delete as appropriate)
